## **Report of the Vestry (Trustees' report)**

### **Year ended 30 September 2010**

As the Charity Trustees of St Mary's Church, the Vestry presents its report and accounts for the year ended 30 September 2010. These have been prepared in accordance with the requirements of the Statement of Recommended Practice: Accounting and Reporting by Charities (March 2005).

#### **Structure, governance and management**

The Church is an unincorporated association, governed by a Constitution which was updated in 2004. For the purposes of charities law, the members of the Vestry are the Charity Trustees of the Church. The Church is a member congregation of the Diocese of St Andrews, Dunkeld and Dunblane in the Scottish Episcopal Church. The Bishop of the Diocese has pastoral oversight of all the constituent congregations, who are subject to Canon Law of the Scottish Episcopal Church. The members of the Vestry normally hold office for four years and are elected at the Annual General Meeting. The Lay Representative who represents the church at Diocesan Synod is elected annually by the lay members of the congregation at the Annual General Meeting. The Vestry Chairman, Secretary and Treasurer are appointed by Vestry. The Vestry has delegated specific powers to its Worship & Music and Stewardship teams, which regularly report and submit recommendations to the Vestry. The Rector is appointed by the Vestry and the Bishop of the Diocese.

The Vestry is responsible for managing and safeguarding the assets of the Church on behalf of the Diocesan Trustees and all other temporal matters including appointing staff, and assists the Rector and Lay Reader in matters affecting the spiritual welfare of the congregation.

Members of the Vestry are provided with a copy of "Guidance for Charity Trustees" issued by the Office of the Scottish Charity Regulator when appointed and will in future receive an induction pack outlining their roles and responsibilities.

The Vestry regularly reviews the strengths and weaknesses of the Church, and will continue to assess the associated risks and opportunities in the context of the new Diocesan Policy.

#### **Objectives and activities**

The objectives of the Vestry are to advance the mission of the Christian Church, through worship, service, and fellowship. These objectives are carried out through mission and pastoral activities. The principal activities of the Church are public worship and the spiritual development of its members.

Donations are made regularly to charitable causes that provide benefits to disadvantaged individuals and communities in Scotland, the rest of the United Kingdom and overseas.

In carrying out its objectives the Vestry depends upon the contribution, both human and material, of many volunteers from the congregation. Activities carried out include contributions preparatory to and during worship, service on Vestry teams and through group activities, the maintenance of premises and fabric, and a variety of pastoral and social activities. These contributions are all highly valued and all members of the congregation are encouraged to, and many do, participate in them.

## **Achievements and Performance**

During the past year the Vestry has confirmed its commitment to the 'Casting the Net' initiative launched by the Diocese in 2009, and will use this to develop a forward vision for the development of St Mary's mission. Following the Bishop's meeting with Vestry in July, the formation of a CTN Mission Planning Group from members of St Mary's is now being actively pursued to progress this. One aspect of our mission is the varied use of our beautiful Church building as a means of strengthening our working links with others in the wider community. As the only Episcopal Church serving over 15 villages in the Trossachs and Strathendrick area, we are well placed for this task, and the Rector's regular monthly services in Balfron and Killearn already provide a focus for spiritual outreach we can build on. Our Church Giving Fund may also have a pro-active supporting role in offering help to vulnerable social groups in the area.

With the completion of the Renovation Project we can now enjoy the transformation of our Church building after some 18 months of almost continuous work by a variety of contractors and specialist craftsmen. The results have included several highlights that were not part of the original works schedule but were added to it as work progressed, in full consultation with the Diocese and congregation. These features include the successful relocation of the stained glass into the west window, the new internal lighting scheme, and the replacement of the short pews with new chairs in the chancel crossing. The provision of an attractive triptych interpretation panel mounted on the wall of the west end of the nave now tells the visitor the story of how the Church came into existence and records the various stages of its renovation in 2008-09.

On Palm Sunday we welcomed a number of guests to a special service for the re-dedication of St Mary's and its congregation led by the Bishop, followed by an excellent lunch in the Aberfoyle Memorial Hall, to celebrate this major milestone in the history of St Mary's. This was preceded by two fundraising concerts given by the Lyra Vocal Ensemble and the Telemann Ensemble, each enjoyed by over 90 people, marking the start of a planned number of musical and other events to be held in the Church each year. Over the summer we welcomed the return of the very popular Kyiv Accordion Duo and we hosted an evening of Scottish folk music performed by local young people in the Stushie and Bow Mhor groups. We have received many favourable comments from first time visitors on the high quality of venue for public events like these which St Mary's now offers.

In June we learnt with regret that Hunter & Clark Ltd, the main contractors to the Renovation Project, was being placed in administration. Fortunately, this happened shortly after the expiry of the period for the final settlement of retention monies and thus had no impact on the satisfactory completion of all fabric repair works.

As noted in last year's report, after taking into account all the elements of the Renovation Project including the final figure of Heritage Lottery Fund grant and the settlement of all contractor payments, there was a small funding shortfall of £5,000 on total outlays of £316,000. To cover this, an internal transfer of funds has been made from the General Fund as shown in the Accounts. Additionally, in order to carry out some of the additional works, Vestry has accepted interest free loans from two members of the congregation, and this represents a significant liability which will have to be met in future years.

Further assistance was given in the form of a short term bridging loan of £10,000 from the Scottish Episcopal Church to cover a negative cash flow position over the closing stages of the Renovation project, and this will be repaid shortly as noted in the Accounts. As always, the Vestry has continued to benefit from helpful support and advice from the Diocesan Office over this and other matters, which is much appreciated.

## **Financial Review**

### *Results*

The General Fund produced an operating deficit of £3,459 in the year, a disappointing outturn which largely reflects a static baseline of congregational giving which has failed to keep pace with increases in clergy and ministry costs. To some extent this position may also reflect the recent exceptional demands placed on members of St Mary's by the Renovation Project. There is no doubt, however, that the Vestry will have to address the need for a renewed stewardship initiative in the coming year. Fortunately, the year end position of the General Fund was helped by a gain of £3,080 in the market value of investments.

The completion of the Church Renovation project with the use of loan funding noted above has resulted in a substantial net outflow of £36,578 from the Renovation Fund, with total works expenditure in the year amounting to £64,260. The closing negative balance of £18,267 in this Fund closely reflects the current extent of external loans, as noted in the Accounts. A review of the long term role of this Fund will be taken in 2011.

The Church Giving Fund was actively used to make donations totalling £1,200 to five UK registered charities. All of these were nominated by members of St Mary's personally connected with their work or, as in the case of the Haiti Earthquake Appeal of Medecins Sans Frontieres, was a cause which Vestry considered particularly important; our donation of £400 included the proceeds of a special Sunday collection.

Overall, the above three Funds declined in value by £37,850 in the year and now stand at 53% of their equivalent value a year previously. The coming year will require all of Vestry's discipline and vigilance in strengthening the reserves in the Balance Sheet.

### *Reserves Policy*

The Vestry's policy is to maintain reserves so that cash and investment income is sufficient to meet three months normal operating costs and any other committed expenditure. The unrestricted cash balance held in the General Fund at 30 September 2010 was £2,898 and anticipated annual income from investments was £1,600. Measured against three months normal operating costs (net of St Andrew's Callander's share) of approximately £10,000, this position highlights the need to strengthen cash flow over the coming year, particularly when the future repayment of loans is also taken into account.

### *Investment Policy*

Investments are held in a range of financial stocks and shares managed by Smith & Williamson. The investment objective of the Vestry is to achieve a balance between longer term growth and current income through discretionary management in accordance with the ethical investment policy of the Scottish Episcopal Church, which excludes investment in any company deriving more than 15% of its revenues from trading in tobacco, armaments, gambling or pornography.

## **Plans for Future Periods**

The Vestry will continue its range of present activities in the foreseeable future. The forthcoming work of the 'Casting The Net Mission Planning Group' will be an important tool to enable St Mary's to strengthen the commitment of St Mary's members to local initiatives which address social and spiritual issues affecting members of the surrounding community.

## **Statement of Responsibilities of Members of Vestry**

Charities Law requires the persons concerned in the management or control of every recognised body to prepare accounts for each financial year which give a true and fair view of its state of affairs and of its results for that period. In preparing those financial statements the members of the Vestry are required to:

- Select suitable accounting policies and then apply them consistently
- Make judgements and estimates that are reasonable and prudent
- Prepare the accounts on the going concern basis unless it is inappropriate to presume that the Church will continue in operation.

The members of the Vestry are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Church and to enable them to ensure that the financial statements comply with the relevant legislation. The members of the Vestry are also responsible for safeguarding the assets of the church and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

## **Conclusion**

In conclusion, the Vestry wishes to thank all members of St Mary's congregation who help in so many different ways in carrying on the work of the Church and without whom nothing would be possible. We also record our appreciation and thanks to all the funding bodies, contractors and outside professionals for their support and input to the completion of our Church Renovation project. In the coming year, we look forward to seeing the work of our Mission Planning Group under the 'Casting The Net' programme strengthen the working links between the St Mary's community and other networks by bringing more people into a meaningful relationship with our Church.

# **Independent Examiner's Report to the Vestry of St Mary's Episcopal Church, Aberfoyle**

I report on the accounts of the charity for the year ended 30 September 2010 which are set out on pages 9 to 16.

## **Respective responsibilities of trustees and examiner**

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1) (a) to (c) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

## **Basis of independent examiner's statement**

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

**NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 30 SEPTEMBER 2010**

**1. Accounting policies**

**Basis of preparation of accounts**

The accounts have been prepared under the historical cost convention as modified by the revaluation of investment assets and are in accordance with applicable accounting standards, the Charities Accounts (Scotland) Regulations 2006 and Accounting and Reporting by Charities: Statement of Recommended Practice (SORP) issued in 2005.

Note 2 explains the general purposes of St Mary's funds.

**Tangible fixed assets and depreciation**

Heritable properties are shown at cost, and expenditure on fabric renovation and repairs is treated as revenue expenditure. Depreciation is not provided on heritable properties. The heritable properties have useful lives in excess of fifty years. No depreciation has been provided against the book value of heritable properties as, in the opinion of the Vestry, due to the long useful economic lives of the properties and their high residual values, any depreciation charge and resultant accumulated depreciation are immaterial. In the opinion of the Vestry, no impairment of the carrying values has occurred during the year.

Expenditure on other tangible fixed assets is charged to revenue as incurred.

**Fixed asset investments**

Investments are shown at market value and the net movement in the year arising from disposals and acquisitions of stock, adjusted by unrealised gains and losses at the year end, is included in the Statement of Financial Activities.

**Congregational giving, donations, legacies and grants**

Congregational giving is accounted for when received. Donations, legacies and similar voluntary receipts are accounted for when St Mary's becomes entitled to the income and a reliable estimate of the amount to be received can be made. Gift Aid tax recoverable is accounted for at the point the tax reclaim is submitted to HMRC. Grants due are accounted for when submitted for payment in compliance with the donor body's conditions.

**Disposals of investments**

Realised gains and losses on the market value of investments are recognised on the date of disposal and are included in the Statement of Financial Activities.

**Governance Costs**

Governance costs relate to expenditure necessary to provide the governance infrastructure which allows St Mary's to operate and to generate the information required for public accountability.

**Apportionment of Support costs**

Resources expended are shown in the Statement of Financial Activities categorised by charitable activity and governance costs in accordance with the requirements of the Statement of Recommended Practice. Certain costs and grants awarded are capable of direct attribution to the categories; however other costs, in particular those of non clergy personnel and those associated with running the Church and Rectory buildings, are attributable to more than one category. These costs have been apportioned to the specified categories based in proportion with the direct costs. (See note 5)

## 2. Funds

Unrestricted funds are available for use at the Vestry's discretion in furtherance of the Church's objectives; restricted funds are those given for specific purposes. Designated funds are unrestricted funds that have been allocated for a specific purpose by the Vestry. St Mary's has three Funds:-

### Unrestricted Funds:

**General Fund** Funds held for the general work of St Mary's as a church, including routine maintenance of the Church building and the Rectory. The balance held in the General Fund will at any time cover any deficit retained in the restricted funds. The value of all capitalised improvements and additions to church buildings are held in the General Fund.

### Restricted Funds:

**Renovation Fund** Funds currently held for carrying out the major fabric renovation programme of the Church building begun in 2008 and completed in 2010. All funds and grants given to the Renovation Appeal for this purpose have been credited to the Renovation Fund which has financed the works, all of which have been categorised as fabric repairs and treated as revenue expenditure.

**Church Giving Fund** The Vestry regularly approves grants to UK registered charities nominated by members of the congregation, which are usually causes with a working connection to members of St Mary's. Special collections at the Christmas Carols and Harvest Festival services, and the associated Gift Aid tax recoverable, are credited to the Fund for this purpose.

No employee received emoluments in excess of £60,000.

Information regarding stipendiary members of the clergy, who are technically not employees but office-holders, is included above.

Employees are eligible to join the Scottish Episcopal Church Pension Fund which is a non-contributory defined benefit scheme with benefits based on final pensionable salary. The Rector is a member of the Fund. St Mary's is unable to identify its share of the underlying assets and liabilities of the Fund on a consistent and reasonable basis and so accounts for its contributions as if the scheme was a defined contribution scheme. The contribution rate for the year under review was increased to 34.9% based on the recommendations of the Fund's Actuary following the periodic valuation of the Fund. There were no contributions outstanding at 30 September 2010 in relation to St Mary's employees.

#### 4. Trustees remuneration, benefits and expenses

Except for the Rector, no member of the Vestry received remuneration or reimbursement of expenses other than reimbursement of purchases made on behalf of the Church. The Rector is *ex officio* a member of the Vestry and a trustee, and receives remuneration, benefits and reimbursement of expenses in respect of services as a stipendiary cleric in line with scales determined by General Synod of the Scottish Episcopal Church.

#### 5. Resources expended on charitable activities

Resources expended on charitable activities include direct costs, grants awarded and support costs. Support costs, which relate primarily to sundry expenses and running the Church and Rectory buildings, are attributable to more than one category. These have been apportioned to the specified categories set out below.

The Church building and the Rectory, both in Main Street, Aberfoyle are owned by St Mary's. The original cost of the Church building and the cost of improvements to it prior to the Renovation project are not known and have not been included because, in the opinion of the Vestry, the cost of professionally valuing them to include a value in the accounts outweighs the benefits to users of the accounts.

On 1 October 2010 the Church and Rectory were insured for £1,663,940 based on a professional valuation of the replacement cost of buildings and contents. Replacement building cost does not represent the market value of the properties, and does not include valuation of the land on which the properties are situated.

St Mary's investments are held in a range of securities managed by Smith & Williamson Investment Management. The Vestry's current investment strategy is to focus on a flexible range of investments yielding a relatively high level of income and to keep these under regular professional review in the light of changing market conditions. During the year, minor adjustments were made to the portfolio, with all the holdings now in collective financial stocks and investment trusts.

## **12. Loans**

During the year, the Vestry carried out a number of improvements to the Church outwith the initial fabric repair programme, subject to securing additional grant or loan funding. These works included full re-wiring, re-lighting, internal redecoration and new carpeting, the upgrade of the Church sound system, new chairs to replace the pews in the chancel crossing, and the refurbishment and replacement of the Church railings. Part of this expenditure has been financed via an interest free loan of £15,000 from a member of the congregation, repayable at £1,000 a year from October 2011. An existing interest free loan of £500 from another member will be repaid in January 2011.

In addition, the Scottish Episcopal Church provided St Mary's with a 1 year bridging loan of £10,000 to cover a temporary negative cash flow position over the closing stages of the Renovation project, and this is repayable in full in December 2010 plus 5% interest for 12 months as provided in the accounts.

## **13. Quota**

Quota is paid by St Mary's to the Diocese of St Andrews, Dunkeld and Dunblane to support the work of the Diocese and of the Scottish Episcopal Church as a whole.

## **15. Future commitments**

At the Balance Sheet date the Vestry had authorised the following committed expenditure as part of the Church Renovation project:-

Replacement of Church railings £5,050

This commitment has been fully funded under the Big Lottery 'Awards For All' grant secured by St Mary's for ancillary works forming part of the Renovation project.

## **16. External Grant Funding – Church Renovation Project**

A final instalment of grant was received as recorded from the Heritage Lottery Fund for the fabric repairs element of the project, as well as further support from the Listed Places of Worship Grant scheme to recover VAT paid on eligible contractors' costs and professional fees.

We are pleased to acknowledge the receipt of a grant for £9,847 from the Big Lottery 'Awards For All' Scotland fund to cover specific additional works to the main project as noted above. We also acknowledge receipt of a further grant of £150 from the E. C. Champness Trust.
